Interest payments on the line of credit totaled \$3,303 during the year ended June 30, 2019.

The date this process was last performed was September 2015, when the new CEO was hired. In September 2017 and September 2019 the Board of Trustees again reviewed the CEO's salary. A comparison of the CEO salaries from 20 other related schools was performed and a merit increase to the current median was approved by the Board of Trustees in each instance. The CFO's salary was reviewed in March 2017, when a new CFO was hired and a salary review was performed by the Board of Trustees. The Board reviewed the CFO salary of 20 other similar organizations and approved the median salary for the CFO.
