The balance of the cash accounts held at the bank totaled \$2,581,318 at June 30, 2018. The principal balance of the loan payable-bonds was \$4,344,494 at June 30, 2018. During the year ended June 30, 2018, the School made payments on the loan payable-bonds totaling \$683,061 of which \$173,427 was for interest. There was no balance payable due on the line of credit at June 30, 2018. The School borrowed and repaid \$1,767,007 on the line of credit during the year ended June 30, 2018. Interest payments on the line of credit totaled \$2,553 during the year ended June 30, 2018.

A form is sent to each individual and they must respond, in writing, to the CFO. The completed forms are kept on file.

Form 990, Part VI, Section B, Line 15 - The process for determining the CEO's compensation is as follows: An independent consultant gathers all the information necessary to provide the Board of Trustees' personnel committee with a recommendation for salary. The personnel committee then reviews the recommendation and approves a compensation package, which becomes part of the CEO's contract. The date that this process was last performed was September 2015, when the new CEO was hired. In September 2017, the Board of Trustees again reviewed the CEO's salary. A comparison of CEO salaries from 20 other related schools was performed and a merit increase to the current median was approved by the Board of Trustees. In March 2017 a new CFO was hired and a salary review was performed by the Board of Trustees. The Board reviewed the CFO salaries of 20 other similar organizations and approved the median salary for the CFO.
